

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.305internationalrealty.com and 305 International Realty LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to 305 International Realty LLC include www.305internationalrealty.com and 305Realty. The 305Realty website is a Real Estate site. By using the 305Realty website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, 305Realty may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- FL Real Estate Sales Associate License Number

If you purchase 305Realty's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

305Realty may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Use of your Personal Information

305Realty may also use your personally identifiable information to inform you of other products or services available from 305Realty and its affiliates.

Sharing Information with Third Parties

305Realty does not sell, rent or lease its customer lists to third parties.

305Realty may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to 305Realty, and they are required to maintain the confidentiality of your information.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by 305Realty. Use of Cookies

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
